Probable Cause Affidavit

Before me this date personally appeared HERNANDEZ, MARCO (765) who being first duly sworn deposes and says that on 28 day of April, (year) 2009 at 3015 S UNIVERSITY DR, DAVIE, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

entered the Walgreens. While her mother was inside the Walgreens Ms. Hicks waited in the vehicle with her [REDACTED] one year old and [REDACTED] also one year old. Ms. Hicks adds as she was waiting she remembers seeing a white male later identified as Charles Christman pacing in front of the store.

Christman entered the store and exited with an employee Eugene Voigt, according to Voigt, Christman was telling him "I need to take those kids! Open that door! I need to take the kids" Voigt advises the male did not seem intoxicated, but could not explain why Christman would want to take the kids because Voigt advises when he checked there was no problem with the kids.

However, Christman still persisted that he needed to take the kids placing Sharri Hicks in fear for the safety of the children. Another Walgreens employee by the name of Albert Casas finally exited the store and told Christman he had to stop harrassing the family. The male walked to a vehicle which was parked in the Wendys parking lot and entered a Silver Toyota Solara J15QMN per Sharri Hicks.

Once police arrived on scene a records check of the tag revealed the vehicle to indeed be a Toyota Solara registered to a one Charles Christman DOB 09/08/1957 with a Sunrise address of 8695 NW 24 Ct Sunrise, Fl 33322.

Ofc. Bishop and Ofc. Smith responded to the Sunrise address in search of the suspect. The suspect was not at the residence, however, the officers spoke to a Michael Capobianco who advised he is a friend of Charles Christman and advised Christman is currently homeless and spending his nights at Walgreens Parking lots around town.

Probable Cause Affidavit

Before me this date personally appeared **HERNANDEZ, MARCO (765)** who being first duly sworn deposes and says that on **28** day of **April**, (year) **2009** at **3015 S UNIVERSITY DR, DAVIE, FL** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

Michael supplied Officers with Christman's phone number of 954-675-2476.

In the interim Ofc. Squarini who was canvassing different areas based on the friends statement located a Silver Toyota Solara in the parking lot of CVS Pharmacy (4610 S. University Drive Davie, Fl 33314) with tag of J15QMN. The male occupant was identified as Charles Christman DOB 09/08/1957. The male had on the same clothing which the witnesses described to me on scene (green t-shirt and grey shorts). A show up was conducted and the male was identified by the witnesses as the same male who was enticing the children fro the custody of their parent.

Christman was arrested and transported to Dvaie P.D. for interview. Christman was read Miranda from a prepatred text and advised he wished to speak tpo me without an attorney present. Christman advised "I remember something happened but I don't remember what!" After prodding Christman for several minutes he eventually advised " Maybe I was protecting the kids! Maybe the mom was going to hurt them! I don't know!" Christman did not have a justifiable reason for his actions.

Christman was processed and transported to Broward county Main Jail.
